# ARTICLES OF INCORPORATION

### FOR

# GREAT COMMISSION MISSIONARY BAPTIST CHURCH, INC OF MIAMI, FLORIDA

We, the undersigned, with other persons, a majority of whom are citizens of the United States, being desirous of forming a corporation not for profit under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

### ARTICLE I-NAME

The name of this corporation is: GPEAT COMMISSION MISSIONARY BAPTIST CHURCH, INC OF MIAMI, FLORIDA.

### ARTICLE II-DURATION

This GREAT COMMISSION MISSIONARY BAPTIST CHURCH, INC. OF MIAMI, FLORIDA shall have perpetual existence.

### ARTICLE III-PURPOSE

Section 1. The GREAT COMMISSION MISSIONARY BAPTIST CHURCH, INC. OF MIAMI, FLORIDA is organized and operated exclusively for religous, education, and charitable purposes, and not for monetary profit, for providing, establishing, maintaining, and operating GREAT COMMISSION MISSIONARY BAPTIST CHURCH, INC. OF MIAMI, FLORIDA for the care and treatment of persons needing religious and spiritual attention by renewing the faith of individual persons in our Lord Jesus Christ.

Section 2. The general purpose for which the GREAT COMMISSION MISSIONARY BAPTIST CHURCH, INC. OF MIAMI, FLORIDA is organized is to do all and everything necessary and proper and lawful for the accomplishment of its specific and primary purpose (which may include the transaction of any and all lawful business for which corporations not for profit may be incorporated under Florida Statutes and under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws).

Section 3. The GREAT COMMISSION MISSIONARY BAPTIST CHURCH, INC. OF MIAMI, FLORIDA is authorized to accept, hold, administer, invest, and disburse for religious, educational, and charitable purposes only, such funds as may be given to it by person, persons, or corporations, or earned by it in its activities, to receive and keep gifts and make financial and other type contribution and assistance to other religious, educational, and charitable organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Section 4. The GREAT COMMISSION MISSIONARY BAPTIST CHURCH, INC. OF MIAMI, FLORIDA will not carry on any other activities not per-

mitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding progration of any future United States internal revenue law.

### ARTICLE IV-ADDRESS
