THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF
INCORPORATION FOR THE PURPOSE OF FORMING A NONPROFIT CORPORATION
UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I - NAME

THE NAME OF THE CORPORATION SHALL BE BRAZILIAN CHURCH AGE OF
GRACE OF MIAMI, INC.

ARTICLE II - STATEMENT OF CORPORATE NATURE

THIS IS A NONPROFIT CORPORATION ORGANIZED SOLELY FOR GENERAL
RELIGIOUS AND CHARITABLE PURPOSES PURSUANT TO THE FLORIDA NOT FOR
PROFIT CORPORATION ACT.

ARTICLE III - PURPOSES

THE SPECIFIC AND PRIMARY PURPOSES FOR WHICH THIS CORPORATION

ARTICLE IV - DEDICATION OF ASSETS

THE PROPERTY OF THIS CORPORATION IS IRREVOCABLY DEDICATED TO RELIGIOUS PURPOSES AND NO PART OF THE NET INCOME OR ASSETS OF THIS CORPORATION SHALL EVER INURE TO THE BENEFIT OF ANY DIRECTOR, OFFICER, OR MEMBER THEREOF, OR TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL.

ARTICLE V - MEMBERSHIP

THE CORPORATION SHALL HAVE A MEMBERSHIP DISTINCT FROM THE BOARD OF TRUSTEES. ARTICLE IX - MANAGEMENT OF CORPORATE AFFAIRS

A. BOARD OF TRUSTEES: THE POWERS OF THIS CORPORATION SHALL BE EXERCISED, ITS PROPERTIES CONTROLLED, AND ITS AFFAIRS CONDUCTED BY A BOARD OF TRUSTEES. THE NUMBER OF TRUSTEES OF THE CORPORATION SHALL BE FOUR. PROVIDED, HOWEVER, THAT SUCH NUMBER MAY BE CHANGED BY A BYLAWS DULY ADOPTED BY THE MEMBERS.

THE TRUSTEES NAMED IN ARTICLE VII SHALL HOLD OFFICE UNTIL THE FIRST MEETING OF MEMBERS, TO BE HELD ON MARCH 5, 1994, AT 6:00 P. M., AT 1770 BRICKELL AVE., CITY OF MIAMI, COUNTY OF DADE, FLORIDA, AT WHICH TIME AN ELECTION OF TRUSTEES SHALL BE HELD.

TRUSTEES ELECTED AT THE FIRST ANNUAL MEETING, AND ALL TIMES THEREAFTER, SHALL SERVE FOR A TERM OF ONE YEAR UNTIL THE FIRST ANNUAL MEETING OF MEMBERS FOLLOWING THE ELECTION OF TRUSTEES AND UNTIL THE QUALIFICATION OF THE SUCCESSORS IN OFFICE.
