ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a corporation under the Florida Not For Profit Corporation Act, Florida Statutes §617 et seq. adopts the following Articles of Incorporation for such corporation:

1. NAME. The name of the corporation is:

2. ADDRESS. The principal address of the corporation is:

3. DURATION. The period of its duration is perpetual.

4. PURPOSE. The purpose is to organize and operate an outreach ministry as an organization under Section 501(c)(3) of the United States Internal Revenue Code, not for pecuniary profit, and through that outreach ministry:

- A. to seek and to save that which is lost, including Persons with life-controlling problems, and
- B. to become the earthly example of the life and ministry of Jesus Christ.

In furtherance of those purposes, the Corporation shall have all of the powers enumerated in Florida Statutes §617.0302 and §617.0303.



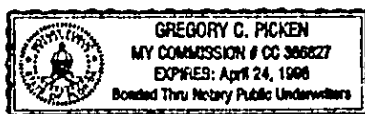


