ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CHRIST COMMUNITY MINISTRIES, INC

Pursuant to the provisions of Section 617.1002 of the Florida Not For Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendments to its Articles of Incorporation:

- 1. The name of the corporation is CHRIST COMMUNITY MINISTRIES, INC.
- 2. The following amendments of the Articles of Incorporation were adopted by the members of the corporation on December 13, 2004, in the manner prescribed by the Florida Not For Profit Corporation Act:

<u>ARTICLE III. PURPOSE</u>

This corporation is being organized for the purpose of Christian work and ministries of all kinds including but not limited to missionary work, religious consulting, and pastoral services, church organization, religious services, education, works of compassion, publications, youth and children services, care for the needs of people in general, and any and all things associated with Christian work for the purpose of fulfilling the call and commands of the Lord Jesus Christ as directed in the Bible and the Bylaws of this Corporation; all with in the purview of the Section 501 (C)3 of the Internal Revenue Code and the Regulation thereunder.

ARTICLE VII. BOARD OF DIRECTORS

This corporation's initial Board of Directors shall have three directors. The number of directors may be increased, from time to time, by an amendment to the corporate Bylaws, but shall never be less than three.

The directors shall be elected annually by this corporation's members. The manner of the election of the directors shall be specified in the corporate Bylaws. The directors named herein, comprising the initial Board of Directors, shall hold office until the election and/or appointment of the directors at the first annual membership meeting and thereafter in accordance with the bylaws.

[The remaining portion of this article does not change.]

ARTICLE VIII. OFFICERS

The officers shall consist of a president, a vice president, a secretary, and a treasurer. The same individual may hold more than one office in a corporation. This corporation may have such other officers as may be provided in the corporate bylaws.

The officers shall be elected annually by the Board of Directors Officers shall be either elected or appointed in the manner and for the terms provided in the bylaws. The manner of the election of the officers shall be specified in the corporate Bylaws. The manner of the appointment or election of the officers shall be specified in the corporate Bylaws. The officers named herein, comprising the initial officers, shall hold office until the appointment or election of officers according to the Bylaws of the Corporation. Directors shall be elected or appointed in the manner and for the terms provided in the bylaws.

[The remaining portion of this article does not change.]

ARTICLE XIII AMENDMENT

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of this corporation's members for their vote. This shall be the only manner for an amendment to be proposed. Such amendments may shall be presented to the membership for their vote and shall be deemed adopted when a vote of 67 percent of the quorum of this corporation's members vote affirmatively to accept the amendment.
