ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE 1

The name of the corporation shall be TADE'S HOUSING SERVICES INC. and the initial principal address of the corporation is:

ARTICLE 111

The general purpose and nature of the business of this corporation is to provide housing services for people with Acquired Immune Deficiency Syndrome (AIDS) in the state of Florida as permitted under the laws of the United States and the State of Florida.


