ARTICLES OF INCORPORATION OF FILIPINO-AMERICAN CHAMBER OF COMMERCE OF NORTHWEST FLORIDA, INC.

<u>Article 1 Name</u> The name of the Corporation is: <u>Filipino American</u> Chamber of Commerce of Northwest Florida, Inc.

Article 2. Duration. The duration of the corporation is perpetual.

Article 3. Purposes. The purpose of the corporation is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to enhance the business environment of Filipino-American businesses in Northwest Florida by sponsoring activities which stimulate economic prosperity, assist new entrepreneurs in starting their businesses, create harmony among the business owners, and promote community development: to follow those policies intended to accomplish the greatest good for the greatest number of people in Pensacola, Escambia County, and other areas of Northwest Florida and to observe all local, state, and federal laws which apply to not for profit reganizations as defined in Section 501 (c) (6) of the Internal Mexenue Code:

B. To exercise all rights and powers conferred by the laws of the State of Morida upon non-profit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by non-profit corporations under the Internal Revenue Code, and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The By-laws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the By-laws, but who shall not have the right to vote.
