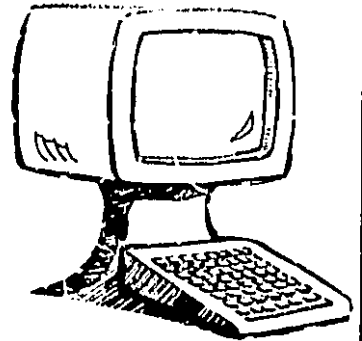

ARTICLES OF INCORPORATION
OF
STAR OF BETHLEHEM CHURCH OF GOD FIRSTBORN INC.

ARTICLE I - NAME

The name of this corporation is: STAR OF BETHLEHEM CHURCH OF FIRSTBORN INC.

The principle place of business is: 3376 W. Broward Boulevard, Ft. Lauderdale, Fl. 33311.

The mailing address is: c/o Pastor Jocelyn Burris, 3200 N.W. 41st Street, Lauderdale Lakes, FL. 33309

ARTICLE II - PURPOSE

The purposes for which the organization is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

This corporation is a NOT-FOR-PROFIT corporation and is not organized for the private gain of any person. It is organized under the nonprofit Public Benefit Corporation Law for charitable purposes.

ARTICLE III- SPECIFIC PURPOSES

The specific purposes of this corporation are:
(1). To cultivate, promote and extend the teachings and practices of the Bible.

(2). To receive Tithe, Offerings, gifts, and Bequests, in order to promote the purpose of the corporation.

(3). To exercise all rights and powers conferred by the laws of the State of Florida upon Non-Profit Corporations.

ARTICLE - IV REGISTERED AGENT

The initial Registered Agent name and address is:

ARTICLE - V ORGANIZATION

A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office.

ARTICLE VI- CORPORATE ASSETS

Upon the dissolution of the Corporation, assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes, and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

ARTICLE VII-DIRECTORS

The initial Board of Directors will consist of three (3) members. The number of directors may be increased or decreased by amendment of the bylaws, but, shall in no case be less than three. Directors shall be elected by the Members at the annual meetings and shall serve until their successors have been elected and qualified.

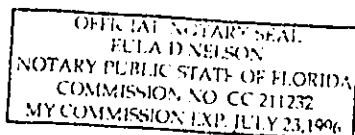
