ARTICLES OF INCORPORATION  
OF

**WEST TAMPA CENTENNIAL SOCIETY, INC.**  
a non profit corporation

The undersigned, for the purpose of forming a non profit corporation under the Florida Non Profit Corporation Statutes, Chapter 617, do hereby make and adopt the following Articles of Incorporation:

ARTICLE I.

NAME, ADDRESS AND MAILING ADDRESS  
OF THE CORPORATION

The name of this corporation is:

**WEST TAMPA CENTENNIAL SOCIETY, INC.**  
a non profit corporation

## ARTICLE II.

### NOT FOR PROFIT

The Corporation is a corporation not for profit as defined in Section 617.01, Florida Statutes. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors or Officers, except to the extent permissible under the law.

## ARTICLE III.

### DURATION

The duration of the Corporation is perpetual.

## ARTICLE IV.

### PURPOSE

The Corporation shall be operated exclusively for charitable, scientific, literary and/or educational purposes and as described in Section 501(c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent Federal Tax Law, including but not limited to the following particular purposes:

a. To preserve, publish and commemorate the rich, diverse, cultural history of West Tampa.

b. To exercise all rights and powers conferred by the laws of the State of Florida upon non profit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any purposes set forth herein.

c. To do such other things as are incidental to the purpose of the corporation or necessary or desirable in order to accomplish them.

## ARTICLE V.

### LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its Members, Directors or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article 4 (Purpose) hereof.

## ARTICLE VI.

### MEMBERSHIP

The qualifications for Members<sup>& Directors</sup> and the manner of their admission shall be provided for in the ByLaws.

## ARTICLE XIII.

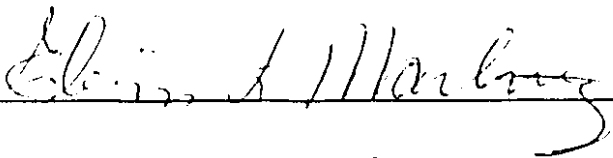
### NONSTOCK BASIS

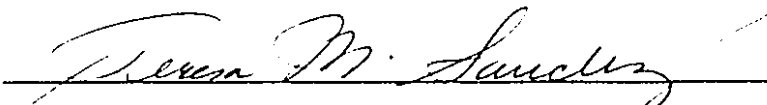
