Article I

NAME

The complete legal name of the Corporation is TAU KAPPA EPSILON

Article II

DURATION

The term of existence of this Corporation is perpetual. The
Corporate existence will commence on the filing of these
Articles by the Department of State.

Article III

PURPOSE

The specific and primary purpose for which this Corporation is
organized is to conduct the business of a college fraternity
the net earnings of which are devoted exclusively to religious,
charitable, scientific, literary, educational and fraternal purposes.
This Corporation shall not, as a substantial part of its
activities, carry out propaganda or otherwise attempt to

NON-STOCK BASIS

This Corporation shall not issue shares of stock.

Article V

DEDICATION OF ASSETS

The property of this Corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of this Corporation shall ever inure to the benefit of any private individual.

Article VI

The By-Laws of the Corporation shall be adopted by the Board of Trustees.


Article XII

DISTRIBUTION OF ASSETS


