#### ARTICLES OF INCORPORATION

OF

### FAST PITCH OFFICIALS ASSOCIATION OF CENTRAL FLORIDA, INC

#### ARTICLE I

Name. The name of this Corporation is: FAST PITCH OFFICIALS
ASSOCIATION OF CENTRAL FLORIDA, INC.

#### ARTICLE II

<u>Duration.</u> The term of existence or the Corporation is perpetual and shall begin on the date of filing of these Articles.

#### ARTICLE III

Purposes. The general purposes for which this Corporation is organized are as follows:

- A. To improve and perpetuate competent softball officiating at all levels of play.
- B. To provide auxiliary services to sporting events in the Central Florida area.
- C. To secure cooperation in advancing the common interest of the members hereof.
- D. To generally exercise all rights and powers conferred by law for non profit corporations.
- E. To do such things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

#### ARTICLE IV

<u>Directors.</u> There shall be three (3) members of the initial Board of Directors of the Corporation. The names, residential and mailing addresses of the persons who are to serve as Directors until the election are as follows:

The Directors shall be elected by secret ballot of the members at each annual meeting. The Board shall establish the policies of the Corporation.

#### ARTICLE V

Officers. The daily affairs of the Corporation are to be managed by a President, Vice President, Secretary, Treasurer, Commissioner, one (1) Umpire at Large, and the Immediate Past President. #### ARTICLE VII

By-Laws. The By-Laws of the Corporation are to be made, altered or rescinded by the members of the Corporation.

#### **ARTICLE VIII**

Amendments to Articles. Amendments to the Articles of Incorporation may be proposed by any member of the Corporation and adopted by two/thirds (2/3) vote of the membership present at a regular meeting or a special meeting.

Conduct of Corporate Affairs.
