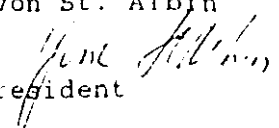

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: Sanctuary, Center for Spiritual Exploration, Inc. (herein after the corporation)

1.1 Duration: The duration of the corporation is perpetual.

ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

Purposes

The specific purposes for which the corporation is organized are:

3.1 (1) To operate exclusively for charitable, educational, spiritual and medical purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1954, as amended (hereinafter the "code").

3.1 (2) To create a nondenominational spiritual Organization, where men and women can explore the limits of the Spirit in order to improve the quality of their individual lives and the lives of others which they come in contact with.

3.1 (3) To come to the aid of fellow humans in need.

3.1 (4) To promote education both locally and abroad.

3.1 (5) To promote spiritual healing.

3.1 (6) To sponsor and organize health facilities both here and abroad.

3.1 (7) To showcase humanity at its finest.

3.1 (8) To raise funds for the functioning of the Corporation.

3.1 (9) To sponsor, organize and conduct seminars, conferences and other group activities of an educational, medical, spiritual, scientific and social nature.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes, which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

ARTICLE IV Manner of election of Directors

The manner in which the Directors are to be elected shall be stated within the bylaws.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

Section 1. Members: The Corporation shall have no members.

Section 2. Founder/Incorporator: The founder, also known as the Incorporator, is irrevocable.

Section 3. Subordination: The Corporation will be subordinate to and subject to the authority of any head or national association, fraternal or beneficial society, foundation, federation or other corporation, society, organization, or association not for profit.

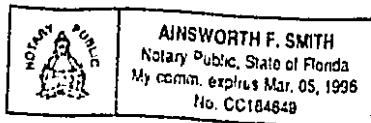
