ARTICLE I. Name

The name of the corporation shall be: South Columbia Youth Baseball Association, Inc.

ARTICLE II. Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be: Post Office Box 44, Fort White, Florida, 32038-0044.

ARTICLE III. Purposes

The specific purposes for which this corporation is a reanized are:

- 1. To teach area youth good sportsmanship, honesty and loyalty; to provide an enjoyable recreational experience for area youth by emphasizing participation instead of perfection; and, to promote the development of strong character and a sense of responsibility and citizenship.
- 2. To help construct, improve, maintain and operate the baseball facilities that are used for accomplishing the above.

The manner in which the directors are elected or appointed is as follows:

Directors shall be chosen at an annual meeting by a majority vote of those members present, each eligible voter being entitled to cast one vote for each vacancy on the Board. Terms of office for the directors shall be for one (1) year. The

beginning of each term of office shall commence fourteen (14) calendar days following elections at the annual meeting.

Vacancies on the Board of Directors shall be filled by the remaining members until the next annual meeting.

ARTICLE V. Limitation of corporate powers

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, without limitation.
