The undersigned, acting as incorporator(s) of this corporation pursuant to Chapter 617, Florida statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I  
NAME AND PRINCIPAL OFFICE

The name of the corporation is Church of Christ-Apostolic (Nondenominational), Inc. The principal place of business shall be 16174 N.W. 27th Avenue, Miami Florida, 33055.

ARTICLE II  
DURATION

This corporation is to have perpetual existence commencing on the date of execution and acknowledgement of these Articles of Incorporation unless dissolved according to law.

ARTICLE III  
PURPOSE

The purposes for which the corporation is organized are:

- (a) To further promote the gospel of Christ.
- (b) To promote spiritual growth and to provide understanding of True Christian living.
- (c) To enhance the total educational process of all members.
- (d) To service as a resource for members who are experiencing difficulty in various aspects of life.
- (e) To exercise all the power conferred upon corporations formed under the State of Florida Non-profit Corporation Act, including but not limited to, the power to accept donations of money or property, whether real or personal, or any interest therein, whenever situated and to engage in activities not illegal under the laws of Florida and the United States of America.

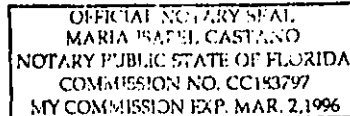

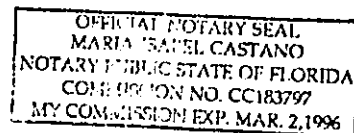
