#### ARTICLE IV

The officers of this corporation shall be the Pastor, Treasurer, and Secretary. They shall have charge of the temporal affairs of the congregation. There shall be a Board of Trustees which shall consist of not less than three (3) or more than five (5) persons elected by the corporation at each annual meeting and each member so elected shall hold office for one year or at the discretion of the Pastor/President. The Pastor shall be the President of the corporation and a continuous member of the Trustee Board. Vacancies on the Board of Trustees shall be filled by election of the corporation at a special meeting or annual meeting or by Pastor/President appointment. The Pastor shall have the power to buy, sell, control, mortgage and manage all personal and real property of the corporation and by and with the consent of the congregation.
