ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 317, Florida Statutes, adopt(s) the following Articles of Incorporation:

**ARTICLE I.
CORPORATE NAME.**

**ARTICLE II.

PURPOSE(S).**



TRU-DEVELOPMENT AND HUMAN SERVICES, INC.

The Undersigned, constituting all of the members of the Board of Directors pursuant to Chapter 617 of the Florida Statutes, hereby adopt the following Restatement of the Articles of Incorporation of TRU-DEVELOPMENT AND HUMAN SERVICES, INC.

ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is: TRU-DEVELOPMENT AND HUMAN SERVICES, INC. The principal office and mailing address is 2297 Edison Avenue, Jacksonville, Florida, 32204.

ARTICLE 2.0 PURPOSE

The Corporation is organized exclusively for charitable, religious and educational purposes as defined under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE 3.0 ELECTION OF DIRECTORS

The Board of Directors shall contain a minimum of three (3) members. The Board of Directors shall be the governing body of TRU-DEVELOPMENT AND HUMAN SERVICES, INC. The chairman of the Board of Directors shall be elected by the membership of the Tru-Way Church of the Risen Christ of Jacksonville, Florida and shall serve until the earlier of his resignation, removal from office or death. The remaining Board of Directors shall be appointed by the chairman for staggered terms as reflected in the Bylaws of the Corporation and each shall hold office for the term to which he is appointed or until the earlier of his resignation, removal from office or death.

ARTICLE 4.0 LIMITATION OF CORPORATE POWERS

The corporate powers of this Corporation are not limited by Section 617.0302 of the Florida Statutes but the Corporation shall not exercise any power or conduct any activity not permitted by a Corporation exempt from federal income tax under Section

501(c)(3) of the Internal Revenue Code.

ARTICLE 5.0 PROHIBITION AGAINST PRIVATE BENEFIT

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2.0 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE 6.0 DISTRIBUTION OF ASSETS UPON FINAL LIQUIDATION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE 7.0 REGISTERED OFFICE AND AGENT
