I, the undersigned for the purposes of forming a corporation under the Florida General Corporation Act, Chapter 617 Vlorida Statutes, do hereby adopt the following introlessor incorporation

ARTICLE I

NAME

The name of this corporation is FEED MY SHEEP MINISTRIES OF THE LORD JESUS, INC.

ARTICLE II

STATEMENT OF CORPORATE NATURE

This is a nonprofit corporation organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act


