**ARTICLES OF INCORPORATION
OF
FEED MY SHEEP MINISTRIES OF THE LORD JESUS, INC.**

I, the undersigned for the purposes of forming a corporation under the Florida Corporation Act, Chapter 617 Florida Statutes, do hereby adopt the following articles of incorporation

ARTICLE I

NAME

The name of this corporation is **FEED MY SHEEP MINISTRIES OF THE LORD JESUS, INC.**

ARTICLE II

STATEMENT OF CORPORATE NATURE

This is a nonprofit corporation organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act

ARTICLE III

PURPOSES

The specific and primary purposes for which this corporation is formed are to operate for the advancement of religion and for other charitable purposes, by the distribution of its funds for such purposes and particularly for such religious, charitable distributions, and education by teaching the word of God

The general purposes for which this corporation is formed are to operate exclusively for such religious purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations qualifying as tax-exempt organizations under that Code

This corporation shall not, as a substantial part of its activities, carry out propaganda or otherwise attempt to influence legislation, nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office

ARTICLE IV

DEDICATION OF ASSETS

The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual

ARTICLE V

MEMBERSHIP

The corporation shall have a membership distinct from the board of trustees. Any person paying dues as provided for in the bylaws and agreeing to be bound by the articles of incorporation

of this corporation, by its bylaws, and by such rules and regulations as the trustees may from time to time adopt, is eligible for membership in the corporation. The trustees shall from time to time prescribe the form and manner in which application may be made for membership.

ARTICLE VI

LOCATION OF INITIAL REGISTERED OFFICE AND NAME OF INITIAL REGISTERED AGENT

The street address of the initial registered office of the corporation is **23 EAST 56TH STREET, CITY OF JACKSONVILLE, COUNTY OF DUVAL, STATE OF FLORIDA 32208.**

The name of the initial registered agent at such address is **Leon T. Stucks**
I hereby accept the designation of registered agent.

ARTICLE VII

INITIAL DIRECTORS

There shall be three directors constituting the initial board of directors, managers, or trustees.

ARTICLE IX

MANAGEMENT OF CORPORATE AFFAIRS

(a) Board of Trustees. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of trustees. The number of trustees of the corporation shall be three, provided, however, that such number may be changed by a bylaw duly adopted by the members.

The trustees named in **ARTICLE SEVEN** shall hold office until the first meeting of members, to be held on **February 1, 1995**, at **2:00 P.M.** at **23 E. 56TH STREET, CITY OF JACKSONVILLE, COUNTY OF DUVAL, FLORIDA**, at which time an election of trustees shall be held, or as the case may be.

Trustees elected at the first annual meeting, and all times thereafter, shall serve for a term of **one** years until the **next** annual meeting of members following the election of trustees and until the qualification of the successors in office. Annual meetings shall be held at **2:00 P.M.** on the first Monday in February of each year at the principal office of the corporation, or at such other

place or places as the Board of Trustees may designate for time to time by resolution

(b) Corporate Officers The board of trustees shall elect the following officers President and Secretary-Treasurer and such other officers as the bylaws of this corporation may authorize the trustees to elect from time to time Such officers shall be initially elected at the first annual meeting of the board of trustees Until such election is held, the following persons shall serve as corporate officers

DISTRIBUTION OF ASSETS
