ARTICLES OF INCORPORATION

95 MAR -3 (MIO: 58 The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Flo Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be " Florida Speed Shooting Association, Inc."

ARTICLE II

The inicipal place of business and the mailing address of this corporation shall be: 2180 NW 107th Ave., Sunrise, Florida, 33322.

ARTICLE III

The specific purposes for which the corporation is organized are:

- A. To encourage organized rifle, pistol, and shotgun shooting among lawfully residing individuals in our community, with a view toward a better knowledge on the part of such residents of the safe handling and proper care of firearms, as well as improved marksmanship.
- B. To forward the development of these characteristics of honesty, good fellowship, self-discipline, team play, and self reliance which are the essentials of good sportsmanship and the foundation of true patriotism.
- C. To foster greater support and understanding of our Second Amendment Rights afforded us in our Constitution.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows:

Upon resignation of the original founding officers, a majority vote by ballot of the members in good standing at the annual meeting of the club. They shall hold office for one year or until their successors are elected. All officers must be National Rifle Association members and at least 21 years of age.

ARTICLE V

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

ARTICLE IX

The assets of the corporation on dissolution of liquidation shall be distributed in the following manner:

To Markham Park Target Range for range development, expansion and shooting equipment or if not accepted by Markham Park to a 501c3 entity or chartered city or county government for purposes of promoting shooting safety and education as determined by the board of directors.

ARTICLE X

There shall be two classes of membership, voting and non-voting. Membership in said classes shall be as follows:

- A Voting The initial directors shall be voting members. The directors of the corporation may select such other members from the non-voting members to have voting member status based on participation in running events and managing the operation of the corporation, activities in furthering the Second Amendment and other goals and objectives in accordance with Article III
- B. Non voting: Non-voting membership shall be by virtue of the dues as determined by the directors. Non-voting membership shall entitle the member to participate in such activities as determined by the board and such other rights and privileges as the board may determine from time to time.
