

ARTICLES OF INCORPORATION  
OF

MISSIONARY CHURCH OF THE WORD OF GOD, (IGLESIA MISIONERA DE LA  
PALABRA DE DIOS,) INC.

We the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, Chapter 617, Corporations Not for Profit, and petition the Secretary of State for approval of such incorporation under the following proposed Articles of Incorporation,

ARTICLE I.

This corporation shall be known as MISSIONARY CHURCH OF THE WORD OF GOD, (IGLESIA MISIONERA DE LA PALABRA DE DIOS) INC. a corporation not for profit.

ARTICLE II.

The place in the State where the principal office of this corporation is to be located at 6852 West Flagler Street, Miami, Florida, 33144.

ARTICLE III.

This corporation is organized as a religious and pious organization and shall be operated exclusively for the worship of our Lord and to preach the holy Gospel all over the territory of the United States of America and throughout the World be it by word, by the press and by the radio and television waves and any other legal means; and by the social welfare of the people. Its net earnings shall be devoted to religious and charitable purposes and no part of those earnings shall ensue to the benefit of any member thereof.

To carry on any kind of activities directed to help the members of the community, such as the promotion of mental health, provision of family counseling, treatment of drug abusers and alcoholism, legal services for underprivileged people, recreation centers for the elderly and all other activities that inure to the benefit of the community.

To foster intellectual and material improvement of the members of the community.

To engage in any lawful act or activity for which corporations not for profit may be organized under the laws of the State of Florida.

ARTICLE IV.

QUALIFICATION OF MEMBERS :

All persons hereinafter named as members, and such other persons as from time to time hereafter the board of Directors may elect by majority vote, including all persons who may be interested in the above objectives and apply for membership and are admitted by a majority of the Board of Directors.

Members shall pay voluntary monthly dues, which sum will be determined by the Board of Directors.

ARTICLE V.

This Corporation is to exist perpetually.

ARTICLE VI.

ARTICLE VII.

The Officers of this corporation shall be a President Director Executive, and a Secretary Deputy Director, and such other Officers as may be stated in this articles.

The Officers shall be elected at the annual meeting of the Board of Directors, or as provided in the By-Laws.

ARTICLE VIII.

The affairs of this corporation shall be managed by a Board of Directors consisting of two (2) regular members of the corporation and by Officers selected by the Board of Directors from the regular membership of the corporation. The Directors shall be elected to regular membership in the corporation annually, or as prescribed

by the By-Laws. The names and addresses of the first Directors who shall manage the affairs of the corporation, until the first annual meeting of regular members, is as follows:

Vacancies in the Board of Directors occurring between annual meetings shall be filled for the unexpired portion of the term by a majority vote of the remaining Directors on nominations made by them among the regular membership of the corporation.

Upon proper notice, the By-Laws may be amended, altered or rescinded by a majority vote of those members of the Board of Directors present at any regular meeting, or any special meeting, called for that purpose.

#### ARTICLE X.

The Articles of Incorporation may be amended at any special meeting of the regular membership called for that purpose by a majority vote of those present.

#### ARTICLE XI.

##### NON PROFIT STATUS.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, Officers or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political -- campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code 1954

(or corresponding provision of any future United States Internal Revenue Law).

ARTICLE XII.

The highest amount of indebtedness or liability to which the corporation may at anytime subject itself shall never be greater than Thirty Thousand (\$30,000.00).
