

# AMENDED AND RESTATED ARTICLES OF INCORPORATION

WAHNETA NEIGHBORHOOD ASSO. INC. 712 South Rifle Range Road Wahneta, Fl. 33880

ARTICLE I
The name of the organization shall be Wahneta Sports and Neighborhood Association, Inc.

### ARTICLE II

The principal place of business and the mailing address shall be: C/O Diana Fields
712 South Rifle Range Road.
Wahneta, Fla. 33880

### ARTICLE III

The specific propose for which this cooporation is organized is: To promote a better community and to sponsor and promote such projects as may be needed or required of a civic nature for the improvement and benefit of the community.

#### ARTICLE IV

- A. The manner in which the executive board is elected or appointed is as follows: One President, One Vice President, One Treasures, and One Secretary's, to to serve a two year term.
- B. The board of Directors shall consist of 11 members which include one president, one vice president, and one treasurer, and one secreetary.
- C. A majority of the board of directors shall constitude a quorum for the transaction of business at any directors meeting, but if at any such meeting there should be less than a quorum, a majority of those present will be a quorm.
- D. The president may at any time change the directors meeting place and time.
- E. Every director present, shall have the right and be entitled to (1) one vote in person. There will be no proxy votes.

- F. The Board of Directors shall have the power to set such policies as may be necessary or desirable from time to carry out the purpose of the corporation.
- G. The board of directors, in accordance with the following section, may increase or decrease the number of members of the board of directors, but there shall never be less than five (5) members.
- H. Any director or Officer who misses three (3) consecutive scheduled meeting shall be advised in writing by the secretary and dropped from the board of directors, unless their reason for absence was given to the secetary prior to the missed meeting.

#### ARTICLE V

The qualification for membership shall require residence and / or ownership within the area designated and referred to as the community of Wahneta. And such surrounding areas as shall be designated by the board of directors.

A. Any citizen of the United States of America who has rendered distingushed service to this organization shall be eligible for honorary membership in this organization.

### ARTICLE VI

All fundraising activites for the corporation or by any members for any purpose shall be by pior approval of the board of directors.

#### ARTICLE VII

Each of the board of directors and the officers has to be elected for two (2) year term.

- A. The president shall be the principal executive officer of the corporation all the affairs of the corporation shall preside at all meeting, shall appoint the members of any committees. Any and all business to be discussed of any committees, and all business to be discussed about the corporation, such as fundraising, ect. shall be taken up with the president before any such business can take place. Any and all papers shall be signed by the president for the corporation.
- B. The vice president in the absence of the president or in the event of the president resignation or inability to act, shall perform the duties of the president, and when so acting shall have all the powers and responsibilities of the president.
- C. The secretary shall keep complete records of the meetings of the board of directors and the general meeting, shall be kept by the treasurer, shall sign such papers as may be kept by the office, or as directed by the board of directors. shall carry on all correspondence of the corporation and shall perform such other duties as may be incidental to the office of the secretary.
- D. The tresurer shall recieve all monies of the corporation and shall have custody ther of. They shall deposit the funds into one or banks as selected by the board of directors to be disbursed in accordance with the directors of the board be disbursed in accordance with the directors of the board and upon signatures of any two president, vice president, and upon signatures of any two president, vice president, and secretary they must keep a full account of all money and secretary they must keep a full account of all money receive and paid out and shall make such report there of to receive and paid out and shall make such report there of to the president and the board of directors as they may require by all government agencies papers of the corporation.
