I, the undersigned, hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of creating a not for profit corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

ARTICLE II

This corporation is incorporated for the purpose of creating a Missionary Baptist Church. The corporation may further engage in any activity or business permitted under the laws of the United States and permitted under the laws of the State of Florida.
