ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

Ladies Elite Club, Incorporated of Manatee County

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

2218 1st Avenue East
Bradenton, FL 34208

Located in the City of Bradenton, County of Manatee, State of Florida.

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

- a. To help ease the many visible social needs that are evident in our community.
- b. To support and foster worthy educational endeavors by 1) adopted a school and each year make a monetary donation to enhance the students at that school, 2) to donate scholarship and book fund to high school seniors who have completed high school with an overall average of 3.0 grade point, 3) to give an Annual Youth Day Festive, for age 11 to 15 years old to encourage them to become productive citizens, get involved with social changing and strive for a better community between adult and youth and to play in a drug free setting without violence.
- c. To provide aides to the elderly in the community through food, clothing, and monetary donations.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

- a. By the members of the club upon a majority vote of fifty (50%) plus one (1).
- b. The Director shall serve for a term of four (4) years.
- c. The Director shall be removed only for just cause, upon two-thirds (2/3) votes of the membership or the Executive Board.

ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

The club shall be empowered to publish papers, pamphlets, newsletters, and bulletins. The club shall be able to raise revenue and receive funds from governmental agencies, private resources, and in general to perform all other acts and things as from time to time would be necessary to effect any and all of the aforesaid purpose to the extent permitted by law.
