ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617 Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

AMERICANS AGAINST CRIME, INC.

ARTICLE II

Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

This corporation will attempt to organize the citizens of the State of Florida to solve the problems within the criminal justice system.

This corporation will attempt to organize the citizens of the State of Florida who live in mobile home parks to expose instances of fraud, deception used by owners and managers of these parks. (see attached)

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

Directors will be elected by vote of members of governing board when said board is validated.

Article 3-Purpose of Corporation

The Corporation shall educate and inform the citizens of the State of Florida, and other States, and legislators, and judges, and prosecutors, of the State of Florida, and other States of: The problems, solutions, alternatives and possible modifications to the criminal justice system in the State of Florida and other States.

The corporation shall educate and inform the citizens, lawmakers, legislators, and others in the State of Florida and other States concerning: The problems in the Mobile Home Park Industry in the State of Florida and other States. The Corporation shall expose possible fraud, deception and bait and switch tactics used by owners and managers of Mobile Home Parks against purchasers, and leasees.

Said corporation is organized exclusively for educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
