#### ARTICLES OF INCORPORATION

#### **FOR**

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

#### **ARTICLE 1 - NAME**

The Name of this Corporation shall be:

# ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

#### **ARTICLE III - PURPOSES**

The Specific Purposes for which this Corporation is organized are as follows: to research and investigate social, economic and geopolitical issues as they relate to the general well-being of the American populace and to the cultural and political institutions of the United States; to educate and inform the general populace as to both the nature of the issues set forth above and on the status and development of the cultural and political institutions referenced above; to encourage participation in the political process by the American citizenry; to conduct all such related business as permitted by law.

### <u>ARTICLE IV - MANNER OF ELECTION OF DIRECTORS</u>

The initial Directors shall be appointed by the Incorporators for a two (2) year term no later than ten (10) days from the filing of these Articles. The method of electing subsequent Directors shall be specified in the Bylaws.

## **ARTICLE V - LIMITATION OF CORPORATE POWERS**

The corporate powers of this Corporation are as provided in section 617.0302 of the Florida Statutes, and shall not be further limited.
