### PURPOSES

3. TO OFFER A SPAY/NEUTER PROGRAM TO HELP ELIMINATE THE PET OVERPOPULATION PROBLEM.
4. TO ESTABLISH A HUMANE EDUCATION PROGRAM TO INFORM THE PUBLIC AS TO THE CARE OF ANIMALS AND THEIR RESPONSIBILITIES TO ADHERE TO THEIR COUNTY AND STATE LAWS.
5. TO GIVE SPEECHES AND EXHIBITS AT SCHOOLS TO TEACH CHILDREN PROPER CARE AND HANDLING OF ANIMALS IN THE HOPE THAT THEY WILL GROW UP TO BE HUMANE HUMAN BEINGS.
6. TO PROMOTE FUND RAISING PROJECTS TO ACCOMPLISH THE ABOVE GOALS.

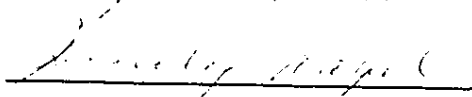

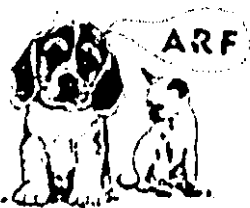

ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF

ARTICLE III. PURPOSES

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The specific purposes for which the corporation is organized are:

1. To operate a Petmobile through which we would find good homes for pets which would otherwise be put to sleep by the pounds and havens, and to help the public find homes for pets they can no longer keep.
2. To establish a harboring program whereby the animals would never have to be put to sleep as long as they are healthy and adoptable.
3. To offer a spay/neuter program to help eliminate the pet overpopulation problem.
4. To establish a humane education program to inform the public as to the care of animals and their responsibilities to adhere to their county and state laws.
5. To give speeches and exhibits at schools to teach children proper care and handling of animals in the hope that they will grow up to be humane human beings.
6. To promote fund raising projects to accomplish the above goals.

ARTICLE V. LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

(A) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section

501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law.

(B) Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.
