FOR

NETWORK YOUTH RESIDENTIAL CENTER, INC.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I
NAME OF THE CORPORATION

The name of the corporation shall be: NETWORK YOUTH RESIDENTIAL CENTER, INC.

ARTICLE II
PRINCIPAL OFFICE

AMENDMENT




