ARTICLES OF INCORPORATION

OF

NORTH BROWARD ALLSTAR TRAVEL BASEBALL CLUB, INC.

The undersigned, desiring to form a Corporation Not for Profit for the purposes hereinafter stated, under and pursuant to Chapter 617 of the Florida Statutes, do hereby declare as follows:

I. NAME

The name of the Corporation shall be NORTH BROWARD ALLSTAR TRAVEL BASEBALL CLUB, INC.

II. NOT FOR PROFIT PURPOSE

The Corporation is being organized for the purpose of undertaking community activities not for profit, including the operating, running and conducting of a traveling baseball team for the members of its team (boys ages 13 to 15) of the NORTH BROWARD ALLSTAR TRAVEL BASEBALL CLUB, INC. and such other permitted purposes. In furtherance of its corporate purpose, the Corporation shall have all general powers enumerated in Section 617.0302 of Florida Statutes, being the Not For Profit Corporation Law, as same may be amended.

III. PRINCIPAL OFFICE

The principal office and mailing address of the Corporation shall be located at 5954 N.W. 74th Terrace, Parkland, Florida 33067.

IV. BOARD OF DIRECTORS

The affairs of the Corporation shall be conducted by a Board of not less than three (3) or as may be modified in accordance with the terms and conditions of the By-Laws of the Corporation. The manner in which the members of the Board of Directors shall be elected shall be as provided for in the By-Laws of the Corporation.

V. INCORPORATORS
