The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

FIRST: The corporate name that satisfies the requirements of Section 607.0401 is:

W B P ALUMNI ASSOCIATION, INC.

SECOND: The purposes for which the corporation is organized are:

To engage and assist in the education and training of the general public in water safety, with specific interest in ocean and open water rescue techniques, the evaluation of related rescue equipment, and its application;

To support and assist ocean and open water lifeguards, rescue organizations, and community swim programs both locally and nationally; and

To engage in any lawful act or activity for which corporations may be organized.

THIRD: The address of the principal office, and the mailing address of the corporation, is 990 Lexington Drive, Dunedin, Florida 34698.

FOURTH: The street address of the initial registered office of the corporation is 990 Lexington Drive, Dunedin, Florida 34698, and the name of its initial registered agent at such address is Robert Love.

FIFTH: This corporation is organized on a non-stock basis.

SIXTH: The method of election of directors is stated in the bylaws.




