ARTICLES OF INCORPORATION  
OF  
GROUP OF ASSOCIATED THEATRE ARTISTS, OF SOUTH FLORIDA, INC.

A Not for Profit Corporation

ARTICLE I

NAME

The name of the corporation shall be:

GROUP OF ASSOCIATED THEATRE ARTISTS, OF SOUTH FLORIDA, INC.

ARTICLE II

REGISTERED OFFICE

The principal place of business and the mailing address of this corporation shall be: 1840 S.W. 29th Avenue, Miami, Florida 33145

ARTICLE III

PURPOSES

The purpose of this Corporation shall be: to educate and inform the community of Florida, and the United States, as to the value of Hispanic and international theatre.

This purpose will be carried out by producing Hispanic theatre, with an emphasis on encouraging new work by Hispanic authors.

ARTICLE IV

MANNER OF ELECTION OF DIRECTORS

The initial Board of Directors shall be composed of the three (3) incorporators whose names are as follows:

At the initial meeting of the Board of Directors, following Incorporation, the full Board of Directors of GROUP OF ASSOCIATED THEATRE ARTISTS OF SOUTH FLORIDA, will be elected, as stated in the Corporation Bylaws.

#### ARTICLE V

#### LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, with no limitations defined herein.

This Corporation shall not carry out any activities not permitted to be carried on by a corporation which is exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954, or any corresponding provisions of future United States Internal Revenue law.
