Pursuant to the provisions of chapter 617, Florida Statues, the undersigned corporation adopt(s) the following Amendments to the Articles of Incorporation for such corporation.

Article 3 - Purpose

Original:

The specific purpose of this Corporation is Exclusively Religious, Charitable and Educational within the meaning of section (c)(3) of the IRS Code of 1986.

Antendment:

The purpose of the corporation is exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article 9

Original:

Upon the dissolution of the corporation, assets will be turned over to one or more organizations which themselves are exempt as organizations described in section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or any corresponding section of any prior or future law, or to the Federal, State or Local Government for exclusive public purposes.

Amendment:

Upon the dissolution of the corporation, assets shall be distributed to one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or any corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for public purposes. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then
