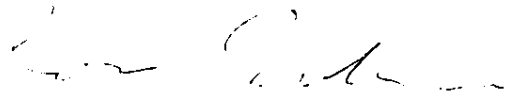

OF

The undersigned, acting as Incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE - NAME

The name of this corporation is Deerpoint Lake Assembly of God, Inc. (hereinafter referred to as the "Corporation").

ARTICLE TWO - DURATION

The duration of the Corporation is perpetual.

ARTICLE THREE - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS
