ARTICLES OF INCORPORATION
FOR
BAHAMIAN/AMERICAN CULTURAL CLUB, INC.

SEP 10 1965

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be: BAHAMIAN/AMERICAN CULTURAL CLUB, INC.

ARTICLE II: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 1861 N. W. 115 Street, Miami, Florida 33167.

ARTICLE III: PURPOSES

The specific purposes for which the corporation is organized are:

- A. To research and to develop the Bahamian/American culture;
- B. To provide opportunities for the interaction between those of Bahamian and/or American ancestry and those interested in the culture;
- C. To promote understanding and respect for various cultural differences, traditions, and customs;
- D. To assist individuals who seek the freedom offered by the American dream;
- E. To conduct any and all lawful business necessary to implement the above purposes.

ARTICLE IV - DIRECTORS

- A. The Directors of the corporation shall be the elected officers of the BAHAMIAN/AMERICAN CULTURAL CLUB, INC., and two (2) members-at-large;

C. The method of election and the terms of office of the Board of Directors shall be set forth in the Bylaws of the corporation.

ARTICLE V - MEMBERSHIP

- A. Membership shall be open to any individual who is interested in broadening his or her knowledge regarding the Bahamian/American culture;
- B. Financial members of the corporation, as defined in the Bylaws, shall have the following rights and privileges of membership:
1. To attend and to have a voice at all general and special meetings of the corporation;
 2. To vote on all motions and any other business requiring approval at general and/or special meetings;

ARTICLE V - MEMBERSHIP (CONTINUED)

3. To elect, pursuant to the procedures described in the Bylaws, the Board of Directors and the officers of the corporation;
 4. To attend all meetings of the Board of Directors;
 5. To be entitled to all other rights and interests, as may be more particularly described in the Bylaws;
- C. Membership in the corporation may be terminated for non-payment of annual dues. A member may be reinstated pursuant to the terms described in the Bylaws;
- D. Membership in the corporation is not transferable.
