Please refer to our letter dated September 17, 1996, copy attached.

We are not a frivolous organization. We take our mission and our obligations very seriously. Our one and only purpose is to help any veteran who needs a little something to get back on his/her feet. As you may or may not know, this is no small undertaking.

The last thing we need is to spend our donations on something for which we are not accountable. We mailed our Annual Report, along with a check for \$61.25 on February 8, 1996. This check has not been returned to us in any form.

Now you wish to charge us another 61.25 plus 175.00 for a reason that could be just as much your error as ours. That makes a total of \$297.50. Do you have any idea what we can do with that kind of money on the streets?

We hereby request a waiver of the \$175.00 penalty. We are willing to pay the second \$61.25 because our first check hasn't been cashed. If you cannot reconsider the penalty, please inform us as to the rights we have regarding an appeal of this situation.

Our ability to raise funds and/or accept donations is at a stand still until we can resolve this problem. Nevertheless we feel it to be unfair to spend honest donations on something as unconscionable as this penalty for which we shouldn't be held responsible.
