- To help maintain or raise the required grade point average of (2.0 G.P.A.) for all members
- To serve as a criminal deterrent for members by conducting clearance checks of all members and requiring each to participate in numerous moral character building projects
- To help maintain a good physical fitness philosophy throughout their tenure as members of the explorer post consistent with entry level requirements (weight must be within reasonable proportion to their height)
- To assist in the overall professional or vocational learning decisions of each member.
- To direct structured discipline to members through our explorer training academy, enabling members to function as a paramilitary unit.
