ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

THIS CORPORATION SHALL HAVE THE RIGHT TO ACQUIRE, HOLD, USE, MORTGAGE, LEASE, SELL, OR OTHERWISE ENCUMBER AND DISPOSE OF REAL AND PERSONAL PROPERTY; TO ISSUE BONDS, PROMISSORY NOTE, BILLS OF EXCHANGE AND FOR ANY OTHER LAWFUL OBJECTS NECESSARY TO CARRY OUT THE GENERAL NATURE OF THE OBJECT OF THIS CORPORATION.

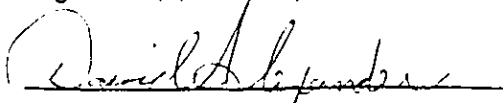

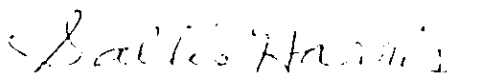
