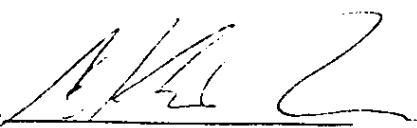

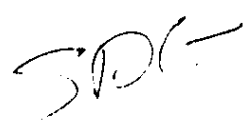

**ARTICLES OF INCORPORATION
OF
IGLESIA RETORNO A PENTECOSTES, INC.**

I, the undersigned subscriber of the Articles of Incorporation, hereby present these Articles for the formation of a Corporation not for profit under Florida Statutes Chapters 617 and 607, as amended, and other laws of the State of Florida.

ARTICLE I

NAME

The name of the Corporation is;

IGLESIA RETORNO A PENTECOSTES, INC.

ARTICLE II

PURPOSE

The purposes for which this Corporation is organized are:

1) To operate exclusively for religious, charitable, scientific, or educational purposes, and any other purposes, and any other purpose described in Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended and/or for any other purpose allowed by Florida Law for a Not-For-Profit Corporation.

ARTICLE III

DURATION

The Corporation is to have perpetual existence commencing at the time of the filing of the Articles of Incorporation with the State.

ARTICLE IV

POWERS

The Corporation shall have and possess all powers and rights conferred upon corporations by the (Florida Not-For-Profit Corporation Act) and any enlargement of such powers conferred by subsequent legislative acts; and , in addition thereto, the Corporation shall have and exercise all powers and rights not otherwise denied nonprofit Corporations by the laws of the State of Florida, as are necessary, suitable, proper, convenient, or expedient to the attainment of the purposes set forth in Article II, herein.

ARTICLE V

PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation is 8719 South U.S. Highway 1, Port St. Lucie, Florida 34952.

ARTICLE VI
DIRECTORS

The initial number of Directors of this Corporation shall be four (4). The number of Directors may be increased from time to time by the Bylaws but shall never be fewer than three (3). The names and address of the members of the first Board of Directors who, subject to the provisions of the Articles of Incorporation and the Bylaws, and the Corporate Laws of the State of Florida shall hold office for the first year of the Corporation's existence, or until their successors are elected and have qualified are:

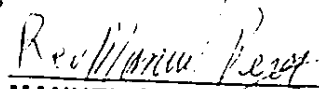
ARTICLE IX
