

ARTICLES OF INCORPORATION  
OF  
OKALOOSA RELEASED TIME, INC.  
(a non-profit corporation)

We, the undersigned have associated ourselves together and do hereby associate ourselves together, for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit, pursuant to the following Articles of Incorporation:

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is OKALOOSA RELEASED TIME, INC. Its principal office shall be located at 5830 South Willow Lane, Crestview, Florida 32539.

ARTICLE II. PURPOSES

The general nature of the objects and purposes of the corporation shall be as follows:

(a) To provide a Released Time Program to guide adolescents in their spiritual, emotional, and character development;

(b) Service will be provided without regard to race, color, religion, sex, age, national origin, or handicap;

(c) The corporation shall own and/or operate a study center or study centers for youth and adults in which Christian education is taught;

(d) To perform in all ways necessary to accomplish the above stated goals.

### ARTICLE III. TERM OF EXISTENCE

The term for which this corporation shall exist shall be perpetual existence unless terminated by lawful dissolution.

### ARTICLE IV. OFFICERS

The officers of the corporation shall be a Director, two (2) Assistant Directors, Secretary and/or Treasurer. The officers shall be members of the Board of Trustees. The manner in which the officers will be elected shall be further set out in the by-laws.

### ARTICLE V. INCORPORATORS

#### ARTICLE VII. BY-LAWS

The by-laws of the corporation shall be adopted by the Board of Trustees and may be amended, altered or rescinded by a majority of the Board of Trustees at any regular or special meeting called for that purpose.

#### ARTICLE VIII. CORPORATE ACTIVITIES LIMITED

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by, (a) a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law or, (b) a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.

#### ARTICLE IX. DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local government for exclusive public purpose.

ARTICLE X. REGISTERED OFFICE

The street address and city of the initial registered office of the corporation is 5830 S. Willow Lane, Crestview, Florida 32539, and the name of its initial registered agent at such address is: Mike Cheney.
