The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### Article I

The Name of the corporation shall be Art for America.

### Article II

The principle place of business and mailing address of this corporation shall be: Rt. 7 Box 4004 Quincy Florida 32351

### Article III

The Specific purposes for which the corporation is organized is to provide free workshops in all fields of the arts for economically disadvantaged communities. This is organization's mission qualifies it for non-profit status under the 501(c)(3) Internal Revenue Code, or the corresponding section of any future federal tax code.

### Article IV

The directors are appointed by committee of the general membership at the annual meeting of the membership on the first day of October.

### Article V

Limitation of corporate powers

A. The Corporate powers of this corporation are as provided in section 617.0302, Florida Statutes

B. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

C. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local, for a public purpose. Any such assets not so disposed of by a Court of Competent Jurisdiction of the county in the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court will determine, which are organized and operated exclusively for such purposes.
