AMENDMENT TO THE
ARTICLES OF INCORPORATION
FOR
IRONWOOD COMMUNITY ASSOCIATION, INC.

Pursuant to Sections 617.1002 and 617.1008 of the Florida Not for Profit Corporation Act, Ironwood Community Association, Inc., a Florida not-for-profit corporation, hereby amends its Articles of Incorporation and states that:

1. The name of the Corporation is Ironwood Community Association, Inc., a Florida not-for-profit corporation, and the Docket Number is: N95000001343.
2. At a Meeting of the Members of the Association held on February 11, 2020, the following Amendments to the Articles of Incorporation were approved by a majority of the Members of the Association, which was sufficient for approval:

ARTICLE FOUR
PURPOSES

The specific purposes for which the Association is organized are:

A. To maintain, repair, **and replace** the potable water distribution system serving the Ironwood Community located in Manatee County, Florida (the "Ironwood Community").

B. - F. Unchanged.


ARTICLE TWELVE
BUDGET AND EXPENDITURES

The Association shall adopt an Annual Budget by majority vote of the Board **which may include funding of reserve accounts for capital expenditures and deferred maintenance** (the "Budget"). All expenditures of the Association shall be in accordance with the adopted Budget. The Board shall have the authority to revise the Budget from time to time as necessary to meet the financial needs and obligations of the Association.
