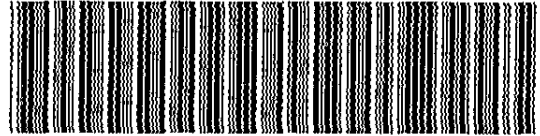

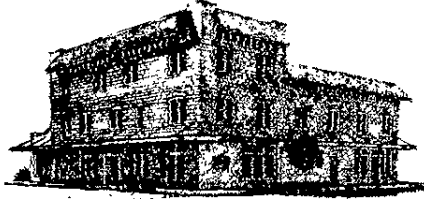

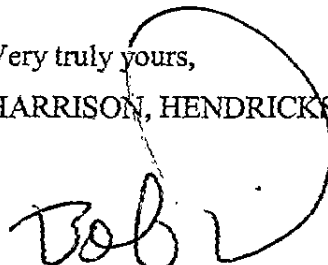

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
FOR
IRONWOOD COMMUNITY ASSOCIATION, INC.

Pursuant to Section 617.1006, Florida Statutes (2002), Ironwood Community Association, Inc. (the "Corporation"), hereby amends its Articles of Incorporation and sets forth that:

1. The current name of the Corporation is Ironwood Community Association, Inc.
2. The text of each Amendment adopted by the Members is as follows:

(a) Paragraph A of Article Four is amended to read as follows: "To maintain and repair the potable water distribution system serving the Ironwood Community located in Manatee County, Florida (the "Ironwood Community")."

(b) Article Six (Members) is amended to read as follows: "Each of the fifteen (15) Condominium Associations created to operate a condominium located within the Ironwood Community shall be a Member of the Association upon signing a Potable Water Agreement. Each individual Condominium Association shall be referred to herein as a "Member" and all of the Condominium Associations collectively shall be referred to as the "Members"."

(c) Article Fourteen (Dissolution of the Association) is amended to read as follows: "The Association may be dissolved upon the affirmative vote of more than two-thirds (2/3's) of the Members; provided, however, the Association shall not be dissolved until it has distributed all of its assets, including monetary assets, to the Members on a prorata basis."

3. The foregoing Amendments were adopted by a majority of the Members at a properly noticed meeting held on March 18, 2003. The number of votes cast for the Amendments was sufficient for approval.

WHEREFORE, the Corporation hereby files the foregoing Articles of Amendment.
