## ARTICLES OF INCORPORATION OF THAIDAM-LAO WOMEN ASSOCIATION, INC

Strate - Say

We, the undersigned natural persons of legal age, acting as incorporators for the purpose of creating a corporation not for profit under the laws of the State of Florida, as provided in Chapter 617 of the Florida Statutes, do agree to the following:

#### ARTICLE I Name

The name of this corporation is Thaidam-Lao Women Association, Inc.

## ARTICLE II Principle place of business and mailing address

The principal place of business and the mailing address of this corporation shall be: The Thaidam-Lao Women Association, Inc., 2660-46th Avenue North, St. Petersburg, Florida 33714

#### ARTICLE III Purpose

The corporation is formed to provide for educational, cultural, social service, and community social activities to insure cultural preservation and promote community development for the empowerment of Thaidam-Lao individuals and families which will enhance successful participation in the greater community.

The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

#### ARTICLE IV Members

The Corporation shall have members, the private property of whom shall not be liable for the debts of the Corporation. The members of this Corporation shall be those persons serving from time to time on the Board of Directors of the Corporation and such other persons as may be selected by the Board of Directors. Qualifications, admission, termination and all other terms and conditions of membership shall be set by the By-Laws of the Corporation as they now or hereafter exist from time to time.

### ARTICLE V Manner of Election of Directors

This corporation shall initially have four directors. The number of directors may be increased from time to time, by the by-laws, but shall never be less than three. The Board of Directors shall be members of the corporation. For method of election see By-laws.

#### ARTICLE VI Officers

The officers of the corporation shall be a President, a Vice President, a Secretary Freasurer and such other officers as may be provided in the by-laws. The names of the persons who are to serve as officers of the corporation until the first annual meeting of the Board of Directors are:

#### ARTICLE VII Limitations of corporate powers

In order to promote the purposes of this corporation, it may acquire property by grant, purchase, devise or bequest, and hold and dispose of such property as the corporation shall require for the benefit of the members and not for monetary

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

### ARTICLE X Dissolution

I pen the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all the habilities of the Corporation, distribute all of the assets of the corporation, exclusively for charitable, scientific or educational purposes in such manner and to such qualified organization or organizations as the Board of Directors shall determine. Any of such assets not so distributed shall be distributed in accordance with the direction of any court having jurisdiction in the county in which the principal office of the Corporation is then located exclusively for the aforesaid purposes of the Corporation to such qualified organizations as said court shall determine. For purposes of this article, an organization is "qualified organization" only if at the time of receiving such assets, it is operated exclusively for the purposes described in Section 170(c)(1) or 170(c)(2)(b) of the Internal Revenue Code of 1986 and is described in Section 509(a)(1), (2) or (3) of said code. Any reference in these Articles to a section of the Code shall be interpreted to include a reference to the corresponding provisions of any applicable future United States Internal Revenue Code.

#### ARTICLES XI By Laws

The Board of Directors of this corporation may provide such by-laws for the conduct of its business and the carrying out of its purposes as they may deem necessary from time to time.

Upon proper notice the by-laws may be amended, altered, or rescinded by a majority vote of those members of the Board of Directors present at any regular meeting or any special meeting called for that purpose.

## ARTICLE XII Amendments

These Articles Incorporation may be amended at a special meeting of the membership called for that purpose, by a majority vote of those present.

Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the by-laws, of intention to submit such amendments.
