These Articles of Incorporation were adopted by the members of the National Cold Storage Association, Inc., on the 10th day of May, 1912, at the annual meeting held at the Hotel Hamilton, New York City.

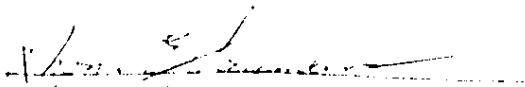

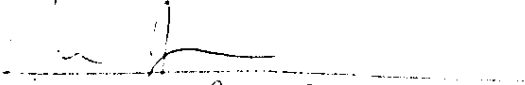

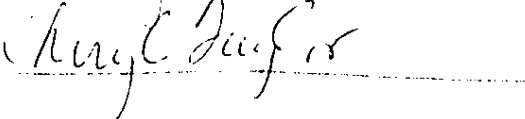
