



ARTICLES OF INCORPORATION
OF LAKE COUNTY ARCHERS, INC.

The undersigned, acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. The name of the corporation is Lake County Archers, Inc.
2. The period of its duration is perpetual.
3. The purpose of the corporation is to establish a non-profit organization, in the business of promotion of amateur archery sports, safety, skills and instruction.
4. Qualifications of members and the manner of their admission shall be regulated by the by-laws.
