ARTICLES OF INCORPORATION for

The Lighthouse Ministry of Orlando, Inc.

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I - Name

The name of the corporation shall be: The Lighthouse Ministry of Orlando, Inc.

ARTICLE II - Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

4409 Carousel Road Orlando, Florida 32808

ARTICLE III - Purpose(s)

The specific purpose(s) for which the corporation is organized is (are): to engage in any lawful act or activity for which corporations may be organized under the general Corporation Law of Florida, including promotion of the gospel of Jesus Christ, fully and to the same extent as natural persons might or could do, and in any part of the world to raise Sunds for economic development of the ministry clients.

ARTICLE IV - Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

This corporation shall have four directors initially that are appointed by consensus of the membership. The number of directors shall be increased to thirty-six, but shall never be less than three. The remainder of the thirty-six directors shall be unamiously appointed by the founders (initial directors) for a term of five years. Subsequent vacancies on the Board shall be filled by the Board of Directors from a list of best qualified candidates elected by the membership at the Annual Meeting.

ARTICLE V - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

MEMPERSHIP

The corporation shall not have any capital stock and the conditions and qualifications of membership shall be, viz:

Fvery member must individually accept and conform to the mission, program, principles and policy of the ministry. Any person who accepts the foregoing shall be eligible for membership provided that said person way membership dues of twenty-five (25) dollars a year to the ministry, or as otherwise determined by the ministry. Upon consideration of applications for membership by Officers of the ministry as to acceptance or otherwise, on enrollment every member shall be supplied with a membership and dues card.

Termination of Membership: Any member or officer may be permanently or temporarily expelled, suspended, or removed after due process in accordance with the provisions of this corporation's by-laws.

ARTICLE VII

DISTRIBUTION OF ASSETS AND PROPERTIES

There shall be no general distribution of monetary or property assets to members except compensation for officers and staff, and all gains realized shall be devoted solely to the implementation of the objectives of the Corporation. No member or officer shall be personally liable to the creditors for an indebtedness or liability incurred, and any and all creditors shall look only to the assets of the Corporation for payment.

In the event of dissolution of this Corporation, its property shall be distributed to such tax-exempt, non-profit organizations as may be selected by the Board of Directors. The assets of the Corporation shall in no event be distributed to any of its members or officers.
