ANNUAL REPORT 2005

The purpose of the Foundation is to increase public awareness of the goals and objectives of Head Start in Hillsborough County and its role in the community; to increase community participation in the Hillsborough Head Start effort; to contribute to improving the quality of Hillsborough Head Start services to children and families; to provide services to and for Hillsborough head Start parents and children; and to serve as corporate body to receive and administer grant funds to supplement the Head Start grant.

During 2005, activities of the Foundation included collaboration with the Young Lawyers for Literacy to provide children's books for all Head Start and Early Head Start families; working with local businesses to improve the environs of some Head Start centers; the establishment and award of the Donna Glausser Scholarship to a Head Start parent of \$2000 for college tuition; the selection of ten Head Start parents to receive \$1000 scholarships for college tuition; the recruitment of local businesses and organizations to partner with specific Head Start centers; the collection and distribution of donated computers to Head Start families; the solicitation, collection and distribution of Christmas presents for every Head Start and Early Head Start child; the purchase of backpacks and school supplies for all Head Start children who graduated from Head Start to kindergarten.

Unfortunately, the major fall fundraising event of 2005, our 4th Annual Breakfast, had to be cancelled due to the unusually severe hurricane season in Florida. This event was rescheduled for March 30th, 2006. Planning and promotion for the Breakfast continued in preparation for the rescheduled Breakfast.
