## ARTICLES OF INCORPORATION

### ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be AMBASSADOR OF JESUS CHRIST MINISTERIAL FELLOWSHIP, INC., with its place of business at 1231 N.W. 60th. Avenue, Sunrise, Broward County, Florida 33313.

## ARTICLE II - ENABLING LAW
