We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:

THE YASHAR FOUNDATION INC.

The address of the principal office of this corporation shall be 22188 Verbena Way, Boca Raton, Florida 33433, and the mailing address of the corporation shall be the same.

ARTICLE II.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to aid in the furtherance of education and communication and toward the creation of an infrastructure for the dissemination of information throughout the world Jewish community.

ARTICLE III
