

CHARTER
OR
ARTICLES OF INCORPORATION
OF
IGLESIA EL CORDERO DE DIOS DE LAKE LAND, INC.

We, the undersigned persons of the State of Florida, all of whom are of age, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit under the laws of the State of Florida, and hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: IGLESIA EL CORDERO DE DIOS DE LAKE LAND, INC. with its principal place of business located at 1919 E. Edgewood Drive, Lakeland, Florida 33803, Polk County, Florida.

ARTICLE II - PURPOSE

To establish and maintain a place for the worship of Almighty God, to provide for Christian fellowship for those of like precious faith where the Holy Ghost may be honored according to our testimony. To preach the Gospel to all ages and teach the Holy Scriptures.

ARTICLE III - PROPERTY

This corporation shall have the power to buy, acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, to borrow money, execute notes, bonds and other evidence of indebtedness and to secure the same by mortgages and deeds of trust, annuity, bond and other instruments of indebtedness and to pay interest thereon, to improve, adapt, and use property held by for Iglesia El Cordero de Dios de Lakeland, Inc. or the income therefrom in the religious, educational, benevolent or social activities of Iglesia El Cordero De Dios de Lakeland, Inc., or its successors without financial profit to its members except as may be necessary in the payment of salaries, or other compensation for services rendered, and the corporation shall have the power to erect and maintain buildings to be utilized by the said church, for the worship of God, for the training in the Christian faith, and to build and maintain residences for the use and occupancy of the ministers of Iglesia El Cordero De Dios de Lakeland, Inc., in conformity with the by-laws of d corporation and all the power a right granted to corporations not for profit under the laws of the State of Florida.

ARTICLE IV - MEMBERSHIP

The members of the corporation shall be all the members in good standing at any given time of Iglesia El Cordero De Dios de Lakeland, Inc., provided however, neither the incorporators nor the members of the corporation shall have any vested right, interest or privilege which may be inheritable, or shall continue after his membership ceases in the aforementioned corporation.

This corporation shall not have the power to buy, mortgage, sell, encumber or deed or dispose of any property which it may acquire, without the consent or the direction of two-thirds (2/3) majority vote of the members, or its successors.

ARTICLE V - TERM

This corporation shall exist perpetually or until dissolved by due process of the law should this corporation cease to exist as a legal entity and its charter be terminated.

ARTICLE VII - OFFICERS

The Officers who are to manage the affairs of this corporation shall be: A President, a Secretary, a Treasurer, and two Directors, which five officers shall be trustees of the corporation, and such other officers as shall be provided for in the by-laws all of whom constitute the official Board of Directors. They shall be elected once a year by majority vote in accordance with the by-laws, and each shall hold office until his successor is elected and qualified, at its regular annual meeting.

The President shall sign and the Secretary shall attest all legal contracts authorized by the members of this corporation and the laws of the State of Florida.

ARTICLE VIII - BOARD OF DIRECTORS

This corporation's affairs are managed by a Board of Directors initially composed of five directors. The number of Directors may be changed from time to time by amendment to this corporation's by-laws, but at all times must be at least three (3). They will be elected every year by the general membership. The names and addresses of the persons who are to serve as the initial directors until their successors have been duly elected and qualified are:

ARTICLE IX - FIRST OFFICERS

The names of the officers who are to manage the affairs of this corporation, and the office which they will respectively hold until their successors are elected and qualified are as follows, to wit:





ARTICLE X - BY-LAWS

The by-laws of this corporation are to be made, altered or rescinded by a majority of the qualified members present and voting at any properly called business meeting of the corporation, which shall be one month in advance of such business meeting, at which a quorum is present.

ARTICLE XI - AMENDMENTS

The Articles of Incorporation may be amended in the manner provided by law. Every amendment must first be approved by the official Board of Directors (trustees), then approved at a duly constituted meeting called for two weeks in advance by the majority of those members entitled to vote thereon.
