



ARTICLES OF INCORPORATION

FOR

ARTICLE I

The name of the corporation shall be: PINE AIR FOUNDATION, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III PURPOSE(S)
