OF

THE FOUNDATION OF THE

(a corporation not-for-profit)

- The name of the corporation is "The Foundation of the Lola B. Walker Homeowners' Association of Coral Gables, Florida, Inc."

- The purposes for which the corporation is organized are for scientific, educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and in this connection its goal is to assist the residents of the portion of Coral Gables, Florida, that is served by the Lola B. Walker Homeowners' Association of Coral Gables, Inc., and the residents of the surrounding neighborhoods to improve the qualit. Their lives.
